Theme: THE ROLE, CONTRIBUTION AND COLLABORATION OF CRITICAL STAKEHOLDERS OF PRIVATE UNIVERSITIES IN HIGHER AND TERTIARY EDUCATION IN THE 21ST CENTURY ZIMBABWE

Background and Context

Education in Zimbabwe has always been supported and anchored by private faith organisations. Some centenarian schools in the country have never ceased to play that role of enlightening society. Most have been known for creating solid and rounded cadres that are not only highly disciplined but also ones that have helped in shaping ideology and patriotism that defines what Zimbabwe is today. Even in the higher and tertiary education sphere, one cannot ignore the contributions by Solusi seminary and a host of mission-based teachers and technical colleges in the land. The end of the 20th into the beginning of the 21st century has seen many private universities coming in to deliver and contribute to higher and tertiary education. For years, Zimbabwe has taken pride in having very high literacy rate in Africa. The existing private universities have always had different besetting experiences as they endeavour to make a contribution to the all-important sector. Some of the known challenges are: poor enrolments largely due to the skewedness of 'favourable fees' being in public universities, high staff turnover rates, as staff find it more lucrative to be in state universities, and failure to expand and become full-fledged universities that offer a full range of degree programmes including those in health and engineering sciences. In some instances, governance issues are raised; whereas the regulator may require to have full establishments of staff within private universities, alternative methods of staff hiring befitting the 21st Century University Education, like visiting lectureship and professorship are not well embraced. With the pronounced Education 5.0 in the land. the higher and tertiary education sector is coming in to create a cadre of professionals that are innovative, skilful and with greater aptitudes beyond literacy. In this light, the state alone cannot fill the big gap hence the acceptance to license private players to also make a contribution. The big question lies in checking on whether or not the 'assistant' wields all the muscle and capacity to get it alone. If university education goes beyond just tutelages and rhetoric, then critical investment though around the higher and tertiary education sector must be seriously interrogated and candidly debated upon. Unfortunately, up to now, there is paucity of this kind of debate.
